- VIII. Student Recognition
- A. State Wrestling Champions
- 1. Bonneville High School Matthew Boone: 2019 State "4A" Wrestling Champion, 195 Weight Class
 Principal Heath Jackson informed the Board that Matt is a three-sport athlete: football, baseball and wrestling. His coaches
 Coach Wadsworth and Assistant Coach Boone, Matt's father, shared the qualities of this athlete. Matt is an outstanding,
 remarkable athlete and other wrestlers look up to him as inspirational leader. Matthew shared his gratitude for all his supporters.
- 2. Thunder Ridge High School Kaden Ramos: 2019 State "5A" Wrestling Champion, 98 Weight Class Athletic Director Cody Jackson and Coach Webb were excited for their first successful wrestling season at Thunder Ridge HS. Kaden is the first State Champion for Thunder Ridge HS. He puts in a lot of work off-season and appreciates the support of this father and school administration.
- IX. <u>Public Input</u>: Pursuant to Board Policy #4105 <u>Public Participation in Board Meetings</u> Public Input shall be held to a maximum of 1 hour and will provide an opportunity for any Board Member, administrator, staff member, student, or patron to raise issues of interest. The Board will receive such input without comment, except to ask germane questions of those speaking.

Comments should be limited to three (3) minutes. The Board will take no action relative to any items during the meeting, but may direct the Superintendent to consider such an item at a subsequent meeting. There was not any public input.

X. Administrative Reports/Information Items

A. Construction Report - John Pymm, Director of Facilities and Operations

Chairman Jenkins invited John Pymm to present construction report on Black Canyon Middle School. Mr. Pymm stated that all the bids are in for the new middle school. Headwaters, the CMGC for the project, is working on the Guaranteed Maximum Price GMP including value engineering; to expedite the project, more than one GMP could be presented. GMP affected by bid alternatives of adding two classrooms and Special Ed areas. Work is underway for canals and utilities. The water line is complete along First Street. Groundbreaking is planned for in early April.

B. Report on the State of the District - Dr. Scott Woolstenhulme, Superintendent

Chairman Jenkins invited Superintendent Woolstenhulme to present report of the District. The purpose of the survey was to see how parents viewed the district and its strength and weaknesses; there were 1000 responses from 750 households. Overall, the District earned a B average. Areas of concern included recruiting and retaining effective teachers and improving teacher effectiveness. The District is currently below the state average for retaining teachers; therefore, the focus is on helping the current teachers become more effective. Recruiting teachers is challenging when numbers of new teachers are falling. Efforts to promote recruiting include job fairs and posting advertisements on college websites. Growth, new schools and the hometown environment in Idaho draw attention to the District. Increasing teacher salaries increases recruitment opportunities.

C. Continued Bond Discussion

Chairman Jenkins opened discussion on the proposed upcoming bond. Dr. Woolstenhulme reviewed the outcome of the Parent Open Houses held at both Bonneville and Hillcrest HS earlier in March. The attendance was low at the open houses; architect displays are posted at each school for visitors to be aware of the pending additions. Opposition to future bonds will be evident and educating the public is most important. Changes in Idaho law relating to tax exemption and bond ballot dates can affect future bonding and the District's 12-year plan. To bond in August is a good plan.

D. Community Engagement - Dr. Woolstenhulme

Chairman Jenkins invited Dr. Woolstenhulme to present information on community engagement. Dr. Woolstenhulme shared the vision of the book, <u>Schools Cannot Do It Alone: Building Public Support for America's Public Schools</u> by Jamie Vollmer and encouraged the Board to be prepared to review and have discussion on the book at the next work session.

- B. <u>Human Resource Director Recommendation</u> Marjean Lewis, Deputy Superintendent
 Chairman Jenkins invited Marjean Lewis to present recommendation for Human Resource Director. The Committee interviewed five candidates for the Director of Human Resources and unanimously selected Heath Jackson for the position.

 MOTION: Chad Dance moved to approve Heath Jackson as recommended for Human Resource Director. Greg Calder seconded. Motion carried.
- C. <u>Surplus Property</u> John Pymm, Director of Facilities and Operations
 Chairman Jenkins invited John Pymm to present information on District surplus property. Many district parcels considered surplus property. Mr. Pymm recommended to surplus the 9/10 acres adjacent to first street access to TRHS; this parcel is not needed for the school and would entail increased maintenance if retained by the District.

MOTION: Greg Calder moved to declare 9/10 acres adjacent to first street access to TRHS and to authorize the District Administration to work with legal counsel to prepare this land as surplus property. Chad Dance seconded. Motion carried.

Additional parcels include land north of the west Thunder Ridge access road: two-acre parcels with frontage on 9th N & 45th E, and two triangular parcels adjacent to current land owners; and five lots that lie in the flood plain north of Mountain Valley Elementary. The Board directed the District to gather more information for further discussion.
